Sub: Outcome / Intimation under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (“Listing Regulations”)

We wish to inform you that Vedant Fashions Limited (“the Company”) had received a notice on *July 3, 2019 & August 17, 2019* from the Department of Legal Metrology, Bangalore (“the Authority”), for violations under offences under Section 18 of the Legal Metrology Act, 2009 of the Legal Metrology Act, 2009 read with Rule 6(1)(d) of the Legal Metrology Packaged Commodities Rules, 2011 in respect of a product for non-disclosure of month and year of the manufacturing/packaging/importing. The Company further received an order dated *May 30, 2025*, from the Authority to compound the case before the compounding authority within 15 days of the receipt of the order or to appeal before the Controller of Legal Metrology, Government of Karnataka. As per the application made before the authority by the Company dated *June 17, 2025*, an amount of ₹ 50,000/- (Indian Rupees Fifty Thousand only) was decided as compounding fee payable. The Company paid the compounding fee on June 26, 2025 (i.e. today) and informed the said Authority by its letter of even date.

The requisite details pursuant to Regulation 30 of the Listing Regulations are shared below:

4. Details of the violation(s)/contravention(s) committed or alleged to be committed – **Month and year of the manufacturing/packaging/importing are not marked**
5. Impact on the financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible – **Except the amount mentioned above, there is no other impact on the financial or operation of the Company.**

We request you to kindly take the aforesaid information on record and disseminate the same on your respective websites.
