Sub: Outcome / Intimation under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (“Listing Regulations”)

We wish to inform you that Vedant Fashions Limited (“the Company”) had received a Show Cause Notice dated *June 17, 2025*, from the Department of Legal Metrology, Ghaziabad (“the Authority”), citing alleged violations under Section 18(1) and 36(1) of the Legal Metrology Act, 2009 read with Rule 26(f) of the Legal Metrology (Packaged Commodities) Rules, 2011. The notice pertains to the non-disclosure of size in standard unit / dimensional specification of a product (i.e., Shawl) available on the Company’s e-commerce platform (www.manyavar.com).

Pursuant to the request dated *June 23, 2025*, made before the authority by the Company, seeking compounding of the aforesaid offence, the Authority issued a Notice dated *July 11, 2025* directing the Company to deposit an amount of ₹ 50,000/- (Indian Rupees Fifty Thousand only) towards compounding fee. The Company has duly paid the compounding fee on *July 16, 2025*, and informed the said Authority by its letter of even date.

The requisite details pursuant to Regulation 30 of the Listing Regulations are shared below:

2. Nature and details of the action(s) taken, initiated or order(s) passed –
Compounding Fee (₹ 50,000/-) decided by the authority for non-disclosure of size in standard unit / dimensional specification of product (i.e., Shawl) on the e-commerce platform.
3. Date of receipt of the direction or order, including any ad-interim or interim orders, or any other communication from the authority – **July 11, 2025**
4. Details of the violation(s)/contravention(s) committed or alleged to be committed – **Size in standard unit/ dimensional specification of Shawl not displayed on e-commerce platform.**
5. Impact on the financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible – **Except the amount mentioned above, there is no other impact on the financial or operation of the Company.**

We request you to kindly take the aforesaid information on record and disseminate the same on your respective websites.
