Ref: Our Earlier Intimation dated June 26, 2025, regarding compounding under the Legal Metrology Act, 2009 by Vedant Fashions Limited (“the Company”)

With reference to our earlier intimation dated June 26, 2025, we wish to inform you that the Company has received the formal compounding order under Section 48 of the Legal Metrology Act, 2009 from the Department of Legal Metrology, Bangalore (“the Authority”). The Order specifies the compounding fees applicable for the offences/violations mentioned therein. 5. Impact on the financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible – **Except the amount mentioned above, there is no other impact on the financial or operation of the Company.**
