Sub: Outcome / Intimation under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations")

We wish to inform you that Vedant Fashions Limited ("the Company") had received a Show Cause Notice dated July 30, 2025, from the Department of Legal Metrology (Weight & Measures), Gautam Budhha Nagar, Noida, Uttar Pradesh - 201306 ("the Authority"), citing an alleged violation under Section 18(1)/36(1) of the Legal Metrology Act, 2009 ("the Act") and the Rules made thereunder. The notice pertains to the non-disclosure of specification of a particular product in its label, available at one of our retail outlets, along with the inconsistencies regarding the declaration about the dimension of its package. In response to this, the Company submitted a request dated August 14, 2025, seeking compounding of the aforesaid offence. Subsequently, the Authority issued a Notice dated August 22, 2025 directing the Company to deposit an amount of ₹ 50,000/-(Indian Rupees Fifty Thousand only) towards compounding fee along with the method of compounding. The Company has duly acknowledged the said notice, deposited the compounding fee on September 04, 2025, and formally informed the Authority via letter dated September 05, 2025.

The requisite details pursuant to Regulation 30 of the Listing Regulations are shared below:

- 2. Nature and details of the action(s) taken, initiated or order(s) passed Compounding Fee (₹ 50,000/-) decided by the authority for non-disclosure of size in standard unit of a product (being Handkerchief).
- 3. Date of receipt of the direction or order, including any ad-interim or interim orders, or any other communication from the authority - September 05, 2025.
- Details of the violation(s)/contravention(s) committed or alleged to be committed Size mentioned on the product found to be non-standard along with inconsistencies in the declaration of the dimension of its package, which are in violation under the Act and the Rules made thereunder.
- 5. Impact on the financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible - Except the amount mentioned above, there is no other impact on the financial or operation of the Company.
