Sub: Outcome / Intimation under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations")

We wish to inform you that Vedant Fashions Limited ("the Company") had received a Seizure Receipt dated *July 24, 2025* and Show Cause Notice dated *August 13, 2025*, from the Senior Inspector, Department of Legal Metrology (Weight & Measures), Ballia, Uttar Pradesh - 277001 ("the Authority"), citing an alleged violation under Section 18(1) of the Legal Metrology Act, 2009 ("the Act") and the Rules made thereunder, which pertain to the non-disclosure of the size on the product label and insufficient space allocated for quantity declaration, which was observed during an inspection at one of the retail outlets. In response to this, the Company submitted a request dated *August 14, 2025*, seeking compounding of the offence with a minimum applicable fee. Subsequently, the Authority issued a Notice on *September 04, 2025*, directing the Company to deposit an amount of ₹ 50,000/- (Indian Rupees Fifty Thousand only) as compounding fee, along with the method of compounding. The Company has duly complied with the directive, deposited the compounding fee on *September 25, 2025*, and formally informed the Authority via letter dated *September 26, 2025*.

The requisite details pursuant to Regulation 30 of the Listing Regulations are shared below:

- 4. Details of the violation(s)/contravention(s) committed or alleged to be committed **Declaration of quantity on the main** display panel of the product did not have the required blank space along with non-disclosure of size on the product label, which are in violation under the Act and the Rules made thereunder.
- Impact on the financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible – Except the amount mentioned above, there is no other impact on the financial or operation of the Company.
