Report on the audit of the Annual Financial Results

Opinion

We have audited the accompanying annual financial results of Vedant Fashions Limited (hereinafter referred to as the "Company") for the year ended 31 March 2026, attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations").

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid annual financial results:

- 1 In terms of Regulation 33 of SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015, this statement of Audited Financials Results of the Company for the three months and year ended March 31, 2026 have been reviewed by the Audit Committee and approved by the Board of Directors at their respective meetings held on May 08, 2026.
- 2 During the year ended March 31, 2026, 29,094 equity shares were issued to employee's of the Company against stock options exercised by them.
- 3 The Board of Directors of the Company, at its meeting held on May 08, 2026 recommended final dividend of INR 7.75 per equity share (par value of INR 1 each) in accordance with section 123 of the Act to the extent it applies to declaration of dividend. This payment is subject to approval of shareholders at the ensuing Annual General Meeting (AGM) of the Company.
- 4 The Company has only one reportable segment - "Branded Fashion apparel and accessories".
- 5 On November 21, 2025, the Government of India notified the four Labour Codes - the Code on Wages, 2019, the Industrial Relations Code, 2020, the Code on Social Security, 2020, and the Occupational Safety, Health and Working Conditions Code, 2020 - consolidating 29 existing labour laws. The Ministry of Labour & Employment published draft Central Rules and FAQs to enable assessment of the financial impact due to changes in regulations. Based on information available, the Company has assessed and recognised the incremental impact of these changes aggregating to Rs. 16.17 millions under "Employee benefits expense" in the statement of profit and loss for the three months ended December 31, 2025. The Company continues to monitor further developments, including the finalisation of Central/State Rules and clarifications from the Government on other aspects of the Labour Code and would provide appropriate accounting effect on the basis of such developments as necessary.
- 6 The Company does not have any investments in subsidiary/associate/joint venture for the year ended March 31, 2026 and thus consolidated financial results are not applicable.
- 7 The figures for the three months ended March 31, 2026 and March 31, 2025 are the balancing figure between audited figures in respect of full financial year and the year to date published figures upto nine months ended December 31, 2025 and December 31, 2024 respectively, which were subjected to limited review.
